



PRESIDENT EIBECK TO SPEAK TO THE PACIFIC COMMUNITY



Pacific President Pamela Eibeck will hold her first Town Hall for the University community at noon on Thursday, September 10 in the DeRosa University Center Ballroom. President Eibeck will talk about the state of the University at the start of the academic year and some of the ideas she brings to Pacific. During the interactive session, the President will both ask and respond to questions.

Eibeck has described these first months of her tenure as a “listening campaign.” She has been working with a transition team made up of deans, faculty members, vice presidents, staff, students and the Board of Regents chair to gain a depth of understanding about Pacific, get to know its people, and be introduced to key external community members. She will be continuing to interact with students, faculty, staff and alumni as she moves through her inaugural year. She has instituted regular office hours for students to help facilitate communication.

The President has announced she will be forming a President’s Advisory Council whose role will be to advise her on matters of importance to the University community; provide a channel of information regarding important developments, initiatives, or issues involving the University; and assist in developing and executing coordinated initiatives and responses. PACIFIC McGEORGE CONSTITUTION DAY FESTIVITIES

FEATURES SUPREME COURT JUSTICE ANTHONY KENNEDY

On Friday, Sept. 18, Supreme Court Justice Anthony Kennedy, the longest-serving active faculty member at Pacific McGeorge School of Law, will celebrate Constitution Day with students and staff in Sacramento. Justice Kennedy will begin with a reception at 10 am.

At 11 am, he will preside over a groundbreaking ceremony for the new Pacific McGeorge Legal Studies Center at the Gordon D. Schaber Law Library entrance. The \$10 million project, a major expansion and renovation of the Gordon D.

Schaber Law Library, is scheduled for completion in 2011. It is the largest facilities project ever undertaken at the Sacramento law school. It will change the face of the 13-acre campus, which has largely remained the same since the mid-1980s.

Kennedy will attend a faculty luncheon following the morning groundbreaking ceremony, then deliver a Constitution Day address to students at 2 pm.

Raquel Aldana, Pacific McGeorge School of Law, co-authored the book, "Understanding Immigration Law," published by Lexis Nexis. Her co-authors are Kevin R. Johnson, Bill Ong Hing, Leticia Saucedo and Enid F. Trucios-Haynes.

Dean Margee Ensign, School of International Studies, will be one of four recipients of the 2009 Peacemaker Awards presented by the Mediation Center of San Joaquin. The award honors county residents who work to promote peace and conflict resolution and make a positive contribution toward building a stronger community. She will be honored at an International Conflict Resolution Day event on October 15 at in Grace Covell Hall.

Marjorie Florestal, Pacific McGeorge School of Law, presented "Risk & Reward: The Gendered Implications of Mutual Mistake Doctrine in Divorce Settlement Contracts," at the Lutie A. Lytle Black Women Faculty Writing Workshop at the Seattle University School of Law.

Fred Galves, Pacific McGeorge School of Law, taught subjects including: Civil Procedure, Business Associations and Securities Regulation, in the 2009 Orientation in U.S.A. Law program for foreign attorneys and LL.M. students at the UC Davis School of Law.

Dennis O. Flynn, Economics, presented two papers at the 15th World Economic History Congress in Utrecht, the Netherlands, in August 2009: "Toward a Price Theory of Moneys" in a session on Monetary Problems and Monetary Policies: the World Economy Before 1800; and "A Unified Theory of Prices" in a session on Money as Commodity. Flynn also co-organized a session on Maritime Trade and Hinterland in Eighteenth-Century Asia.

Bhaskara R. Jasti, Thomas J. Long School of Pharmacy and Health Sciences, was appointed to Fellow status in the American Association of Pharmaceutical Scientists and will be formally inducted at the 2009 AAPS Annual Meeting in November. Jasti is the first at Pacific to receive this honor. AAPS recognizes individuals for outstanding contributions that elevate the stature of the pharmaceutical sciences and professional competence reflected through scholarship and research.

Analiene Richard, School of International Studies, and Daromir Rudnyckyj of the University of Victoria, published their article "Economies of Affect" in the Journal of the Royal Anthropological Institute.

Ruth Jones, Pacific McGeorge School of Law, presented the workshop "Techniques to Improve the Analytical Skills of Students in Large Required Classes," at the Gonzaga Institute for Law Teaching and Learning Summer 2009 Conference in Spokane, Wash. Jones presented "Defining Title VII's 'Because of Sex' in the Context of Sexual Abuse in Prison" and served as a commentator for another session at the Lutie A. Lytle Black Women Faculty Writing Workshop at the Seattle University School of Law.

Tomomi Kinukawa, History, presented the paper "Consumption, Domesticity, and the Construction of Colonial Nature: Maria Sibylla Merian (1647–1717) in Surinam" at the Workshop "Consumption, Power and Culture in the Early Modern Atlantic World" organized and sponsored by Åbo Akademi, Finland. She also presented a paper "'To All the Curious and Diligent Observers of Nature': The Domestic Sphere, Nature Studies and the Early Modern Dutch Empire" at the annual conference of the Pacific Coast Branch of the American Historical Association in Albuquerque, N. M. Kinukawa was selected to attend the Spelman-NWSA Summer Institute, "Women of Color: Theory, Scholarship, and Activism" organized by Spelman College and the National Women's Studies Association and sponsored by the Ford Foundation.

Courtney Lehmann, English, has been appointed to a Doctoral Dissertation Committee for a PhD candidate in the Department of English at the University of Kansas, which will draw upon her expertise in Shakespeare and Popular Culture. Lehmann will attend the defense next spring.

Dugoni School of Dentistry, were co-authors with James and Mei Whittaker of the Oregon Health and Science University on the paper "Expression and characterization of recombinant human secretory leukocyte protease inhibitor (SLPI) protein from *Pichia pastoris*" published in the journal Protein Expression and Purification.

Steve McCaffrey, Pacific McGeorge School of Law, had his article, "The International Law Commission Adopts Draft of International Law Articles on Transboundary Aquifers," published in the American Journal of International Law.

Starting this week, Stockton Campus Pacific employees can utilize the program by adding PacificCash to their PacificCard.

When you purchase an item from any of the on-campus dining venues, simply tell the attendant at the register that you want to use your Employee Meal Program (EMP) dollars to purchase the item. Once doing so, the amount will be deducted from your PacificCash account.

Faculty and staff who purchase items using the Employee Meal Program will receive an automatic 10 percent discount.

Please note that the EMP can only be used by employees with a valid PacificCard ID. The plan is not available using a "department" card. The program has now been activated so be sure to start saving today.

Roshanak Rahimian, Thomas J. Long School of Pharmacy and Health Sciences, and **Leigh Anderson**, Arthur A. Dugoni School of Dentistry, received a grant from the National Institutes of Health for "Blood Flow and Salivary Gland Function in Diabetes." The \$196,200 grant recognizes their collaborative research on "Cellular and Molecular Mechanisms underlying the Loss of Estrogen-Mediated Vasoprotection in Diabetes." The research will contribute to the development of new therapeutic strategies for the prevention and treatment of diabetic microvascular disease.

Merrill Schleier, Visual Arts, was nominated for the Katherine S. Kovacs book award for her book "Skyscraper Cinema: Architecture and Gender in American Film," published in 2009 by University of Minnesota Press. The Kovacs book award is granted for outstanding scholarship in film studies, and is administered by the Society for Cinema and Media Studies.

Xin Guo, Thomas J. Long School of Pharmacy and Health Sciences, together with **Andreas Franz**, Chemistry, were among only three recipients of the TEVA USA Scholars Grant by the American Chemical Society (ACS). The \$300,000 grant supports their research on developing pH-sensitive liposomes for drug delivery. The results will be presented at a national meeting of ACS at the end of the term.

Avantika Kekatpure'10, Thomas J. Long School of Pharmacy and Health Sciences, received the APS Research Recognition Award at the 2009 American Physiological Society (APS) Conference in Broomfield, Colo. **Kekatpure, Roshanak**

Dugoni School of Dentistry, were awarded 2nd place for their poster presentation on "Gender Differences in Aortic Endothelial Function in a Rat Model of Type 1 Diabetes: Possible Role of Superoxide and Cyclooxygenase."

The **Athletic Training Education Program** in the Department of Sport Sciences has received a 7-year accreditation, the maximum number of years awarded, from the Commission on Accreditation of Athletic Training Education (CAATE). The accreditation extends through the 2017–2018 academic year. The Athletic Training Education Program prepares students to become Certified Athletic Trainers.

The **2008 issue of Calliope: Reach and Reflect**, Pacific's Visual and Literary Art magazine, has received the 2009 APEX Award for Publication Excellence. The awards are sponsored annually by Communications Concepts Inc. Calliope was the only publication designed, illustrated and written by students. The rest of the 3,785 entries were all professionally produced and represent a wide range of companies across the country.
