PACIFIC McGEORGE BREAKS GROUND ON NEW LEGAL STUDIES CENTER



Supreme Court Justice Anthony M. Kennedy helped break ground for the Pacific McGeorge Legal Studies Center on September 18 and gave the Constitution Day lecture to students later that day. Kennedy taught constitutional law at the Sacramento law school from 1965 until 1988 when he was sworn in as the 104th justice of the Supreme Court of the United States. He has taught annually in the McGeorge Salzburg Summer Program in Austria since 1989.

The \$10 million law library expansion is the largest building project ever carried out on the law school's

13-acre campus. The Pacific McGeorge Legal Studies Center, which will house the Gordon D. Schaber Law Library, is set for completion in 2011.

Pacific McGeorge Dean Elizabeth Rindskopf Parker; Jamie Sammut, president of the Student Bar Association; and Randy Schaber, nephew of the late Dean Gordon Schaber, joined Kennedy and Eibeck in the ceremonial groundbreaking shovel toss.

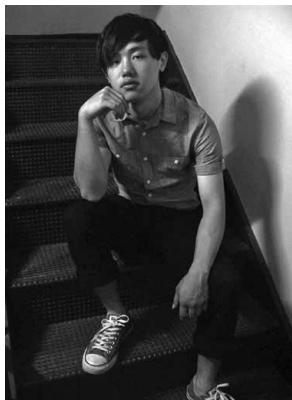

Actor Bee Vang, one of the central actors in Clint Eastwood’s film “Gran Torino” will highlight a panel discussion, “The Real Gran Torino Story: Stockton’s Secret War on the Streets,” on gang violence in the Southeast Asian American community. The event will take place from 5 to 8 pm on October 24 in the DeRosa University Center’s Grand Ballroom. It is free and open to the public. The film “Gran Torino” addresses gang violence in the Hmong community.

The panel discussion organized by Pacific students, will include State Senator Leland Yee, chair of the California Senate Select Committee on Asian Pacific Islander Affairs, as well as officials from the state Office of Attorney General, the City of Stockton, the Stockton Police Department and Stockton Unified School District. The event is co-sponsored by Pacific’s Cambodian, Hmong and Vietnamese student associations, Senator Yee’s office, the Asian Pacific Islander Public Affairs Association — Central Valley Chapter, Lao Family Community of Stockton, Lao Khmu Association, United Cambodian Families and the Asian Pacific Islander Self-Development and Resident Association.

After the discussion, internationally-known Khmer-American hip-hop artist PraChy Ly will perform. Ly often addresses gang violence in his music.
